OFFICIAL RULES

The Cord Blood Registry *Thank Off Contest* Giveaway ("the Giveaway") begins at 12:01 a.m. PT on November 20, 2015 and ends at 11:59 p.m. PT on November 30, 2015 (the "Giveaway Period").

The Giveaway is administered and sponsored by Cbr Systems, Inc. 1200 Bayhill Drive, 3rd Floor, San Bruno, California 94066 ("Sponsor" or "Cord Blood Registry").

1. WHO CAN ENTER:

The Giveaway is offered electronically via (a) Votigo, Inc. application on the Facebook platform at http://www.facebook.com/CordBloodRegistry, (b) Twitter, and (c) Instagram (each, a "Platform"), only within the United States and not where otherwise prohibited by law. Entries will be deemed made by the authorized account holder of the e-mail address submitted at the time of entry if entering via Votigo, or if entering via Twitter or Instagram, the authorized account holder of the Twitter or Instagram account used to enter the Giveaway. - 1. Follow @cordbloodregistry on Instagram.
